## MINOR RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT (READ CAREFULLY BEFORE SIGNING)

## Georgia Practice Facility(GPF) and/or Michigan Motor Cross, Ilc SEPTEMBER 2022-OCTOBER 2023

IN CONSIDERATION for allowing in the below MINOR participant to compete, officiate, observe, work for, or participate in any way in the above event and/or activities ("EVENT(S)") and/or being permitted to enter for any purpose any area of Michigan Motor Cross, LLC., Joshua or Melanie Woods, Raymond or Terry Woods and/or Georgia Practice Facility all hereafter known as GPF (including but not limited to, the competition area, hot pit, paddock or any restricted area (to which the general public is restricted to) EACH OF THE UNDERSIGNED, for himself/herself, his/her personal representatives, and next of kin agrees that:

- 1. THE MINOR AND PARENTS OR GUARDIAN will immediately inspect the GPF properties upon entering it warrants that their entry therein and/or the Minor's Event participation constitutes and acknowledgement that they have inspected the GPF properties and find it safe and reasonably suited for the purpose of its use. The undersigned agree that if at any time they believe something is unsafe, it will be brought to the attention of the OFFICIALS/OWNERS of GPF, and they will remove themselves from the property and the minor will withdraw from participation in any activity at GPF.
- 2. THE MINOR AND PARENT OR GUARDIAN HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OR BODILY INJURY, DEATH OR PROPERTY DAMAGE due to negligence of the releasees (as identified below) or otherwise, while in or upon GPF properties for any purpose and/or while participating in any way in the EVENT(S). The undersigned recognize and understand that there are risks and dangers associated with participation in the EVENT(S) and admission within the GPF properties could cause severe bodily injury, disability and death. Further, the risks and dangers may be caused by the negligent failure to act of the RELEASEES and others. All of the risks and dangers associated with participating in the EVENT(S) and/or entry onto GPF property are assumed not withstanding.
- 3. THE MINOR AND PARENT OR GUARDIAN release, waive, discharge and covenant not to sue the promoters, participants, associations, sanctioning organizations, (or any affiliates thereof), track operators, track owners, officials, builders and designers, drivers, vehicle owners, riders, pit crews, all persons on the GPF property, sponsors, advertisers, owners, lessees and lessors of the premises used to conduct any activity on GPF, premises and event inspectors, surveyors, brokers/underwriters, consultants and others who give recommendations, directions or instructions or engage in risk evaluation or loss control regarding the premises or GPF properties and, for each of them their officers, agents, and employees (all for the purpose herein referred to as "RELEASEES"), from all liability to ourselves, the undersigned, our personal representatives, assigns, executors, heirs, and next of kin for any and all claims. demands. losses damages of the MINOR and/or parent or guardian on account of any injury including, but not limited to, the death or injury of the parent/guardian or MINOR or damage to property, all of which is caused or alleged to be caused by the negligence of the RELEASEES or otherwise.
- 4. THE PARENT AND/OR GUARDIAN hereby agrees to indemnify, and save and hold harmless, the RELEASEES and each of them from loss, liability cost they may incur due, in any manner or degree, to the presence of the parent/guardian or the MINOR on the GPF property, or related in any way to their participation in, or presence at, the EVENT(S) and whether caused by negligence of the RELEASEES or otherwise. The parent and/or guardian further recognize and agree they are executing this Waiver and Release of Liability and Indemnity Agreement on behalf of themselves and on behalf of the MINOR.
- 5. This Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement extends to all acts of negligence by the RELEASEES, INCLUDING
- NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the State or Province in which the is/are conducted, and that if any portion thereof is held invalid, it is agreed that the balance shall, by notwithstanding, continue in full legal force and effect.
- 6.HEREBY The parent and or guardian of minor have provided health insurance coverage to be in effect at all times while on GPF properties to cover cost of any injuries sustained during any activity or event and GPF will not be held liable for any medical charges resulting from injuries. The parent and or guardian initials this statement in acknowledgement of this release of medical cost liability on behalf of themselves and on behalf of the MINOR.
- 7.The parent and/or legal guardian acknowledge that the minor shall be directly supervised at all times by the parent and/or legal guardian while present on the GPF properties which shall include, but is not limited to, the parent and/or legal guardian being physically present at all times on the GPF properties while the minor is present.

THE PARENT OR GUARDIAN HAS READ AND VOLUNTARILY SIGNS THE WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT AND DOES SO VOLUNTARILY AND WITH THE UNDERSTANDING THAT SUBSTANTIAL RIGHTS ARE BEING GIVEN UP. WE FURTHER ACKNOWLEDGE THAT FAILURE TO NOTARIZE THIS AGREEMENT SHALL NOT AFFECT ITS VALIDITY.
